Rajasthan High Court terms live-in relationship with married woman 'illicit', denies police protection

Jaipur: A single-judge bench of Rajasthan
High Court recently termed a live-in relationship between a man and a married
woman "illicit". The bench denied police protection to the woman on August 12, a
she submitted before the court that she wa a victim of domestic violence after which she left her husband's house. The plea was
filed by a 30 -year-old married woman and filed by a 30 -year-old married woman and a

district before the single-judge bench of Justice Satish Kumar Sharma. During the hearing, the counsel for the petitioner
submitted that both the petitioners are submitted that both the petitioners are
adults and are consensually in a live-in relationship. The petition said the woman is
married but has been living separately because of physical abuse by her husband "It is clear from examining all the
documents of both sides that petitione documents of both sides that petitione
number 1 is already married. She has not go a divorce but despite that, she is staying
with petitioner number 2 in a live-in relationship. In such a scenario, the live-in the category of an illicit relationship," says the court order. While passing the order
Justice Sharma also cited a recent order of Justice Sharma also cited a recent order of
the Allahabad High Court, wherein it had rejected the request for police protection in a similar case. Earlier this month, the
Allahabad High Court dismissed protection plea of a married woman staying in a live-in observed observed that live-in-relationship cannot be
at the cost of social fabric of this country. A division bench of Justices Dr Kaushal
