Decomposed bodies of Bengal minister's relatives found in **Asansol**

Kolkata sDecomposed body of state law minister Moloy Ghatak's relatives was found inside their house in Asansol on Monday. Prima facie police suspect it to be a suicide, however, they are yet to confirm the actual cause of death. The deceased have been identified as Joyshree Ghatak (60) and her daughter Neelam (40). Joyshree's husband Ashim Ghatak, elder brother of the state law minister, had died about two years ago. Sources said that since then his wife and daughter were depressed.

"The two bodies were recovered from Hindustan Park area of Asansol. An unnatural death case has been registered. Prima facie it looks like they committed suicide. The autopsy report will reveal the actual cause of death," a police official told The Indian Express.

Asansol Mayor Jitendra Tiwari said, "It is unfortunate. Police officials are looking into it." Minister Moloy Ghatak couldn't be reached for his reaction.

Pune: Complaint filed against two unidentified persons for 'robbing' Rs 7.5 lakh

Pune A complaint has been registered against two unidentified persons for allegedly robbing Rs 7.5 lakh from a 45-year-old woman in Kondhwa on Monday.

According to the police, the complainant moved out of her apartment in Kausarbag area of Kondhwa with the garbage bin around 7.45 am when the two unidentified persons intercepted her. The duo then gagged her and took her inside the apartment, said police. The duo then tied the woman with a dupatta and demanded money, said police. They also threatened the woman by showing a "horrifying" video on their cellphone. One of the robbers pointed a knife at the woman's 11year-old daughter and threatened to kill her if their demands were not met. The duo then robbed Rs 7.5 lakh in cash and took two cheques of State Bank of India from her apartment and fled around 8.45 am, said police. After the incident, the woman approached the police. An offence has been registered under sections 392, 398, 452 of IPC against two unidentified robbers"Probe so far has revealed that one of the robbers was speaking in Marathi and the other in Hindi. Attempts are on to identify and trace them. The victim family had collected the money by selling their apartment in Mahad in Raigad district. Further investigation is on," said Police Sub-inspector Santosh Shinde, who is the investigating officer in the case. Police said there were no CCTV cameras around the crime scene and nobody else was at the house when the robbery incident took place. The complainant lives in the apartment with her daughter, while her husband works at some other place.

SAD sees 'divine justice' in loss of those who raised sacrilege issue during polls

Chandigarh The Shiromani Akali Dal (SAD) Tuesday passed a resolution to express "appreciation and gratitude" to party president Sukhbir Badal for his "tireless and dynamic leadership during this poll campaign, going around the state and mixing with lakhs of workers and other Punjabis". Another resolution said that all those who "pretended" to contest Lok Sabha polls from Punjab on the issue of sacrilege were "thrown out by people" in an act of "divine justice". The party noted that "Akal Purakh responded positively to the prayer of the SAD president Sukhbir Singh Badal" and "decimated all those who committed or planned the sacrilege of Sri Guru Granth Sahib"."The Congress president [Sunil Jakhar] was leading the Congresssponsored elements who had formed the socalled morchas on the sacrilege issue. He was demolished as were his co-conspirators like Sukhpal Khaira , Baljeet Singh Daduwal, Dhian Singh Mand, Simranjit Singh Mann and the so-called Taksalis,' said a resolution adopted Tuesday.

The party also congratulated Sukhbir for "registering the biggest win in these elections, defeating his Congress rival by (nearly) two lakh votes." The party also thanked Harsimrat Kaur Badal on her victory "despite the Congress and all the socalled Panthic elements conspiring against her". In another resolution, SAD came down heavily on the "crushing hike in the electricity tariff in the state". The party also lashed out against the government for the "irregular supply to every sector, especially domestic, farmers and the industry in the state".A core committee resolution expressed "grave concern" concern over the growing incidents of rape and murder in the state "like the one at Dhuri in which a fouryear-old became a victim of the government's failure to control lawlessness." Demanding immediate reversal of the inhuman decision to reduce teachers' salaries, the core committee said it would not allow such injustice against teachers and would stand by them and force the government to take back this anti-people

The Scheme has been given effect in the above financial results for the guarter/year ended 31 March 2019 with Appointed date of 01 April 2017. Pursuant to the Scheme 16,80,896 number equity shares of Rs. 10 each fully paid up of the SCL (Transferee Company) have been allotted to the shareholders of ALL (Transferor Company) on 29 April 2019 and equivalent number of equity shares of Rs. 10 each fully paid up held by ALL (Transferor Company) in the SCL (Transferee Company) have been cancelled. Post allotment of the above equity shares, the paid up equity capital of the SCL (Transferee Company) has been increased to Rs. 4,38,08,960/-The Auditor has reported in its report that the Company not carrying out any manufacturing operations and has incurred

substantial accumulated losses and consequently the net worth of the Company has been fully eroded. The matter was reviewed internally and the management is of the view that the accumulated losses are mainly because of closer of commercial operation for years because of various reasons including unfavorable market conditions and other reasons whereas the Company continue to incur compliance and other cost. However the Management is exploring possible step: in this respect and hopeful for revival measures.
